

PATIENT EDUCATION: IDF PROVIDED EDUCATIONAL PROGRAMS ACROSS THE COUNTRY FOR PATIENTS AND FAMILIES LIVING WITH PRIMARY IMMUNODEFICIENCIES (PI). IN 2015, APPROXIMATELY 13,562 ATTENDED MORE THAN 184 PROGRAMS IN 105 CITIES IN 32 STATES. THESE INCLUDED LOCAL PATIENT MEETINGS, GET CONNECTED MEETINGS, TEEN ESCAPE WEEKENDS AND MEDICAL EXHIBITS. THE IDF 2015 NATIONAL CONFERENCE IN NEW ORLEANS DREW MORE THAN 1,360 ATTENDEES. IDF COORDINATES AN OUTREACH PROGRAM WITH PLASMA COLLECTION CENTERS THROUGHOUT THE COUNTRY. APPROXIMATELY 2,885 PEOPLE WERE REACHED IN 89 VISITS TO PLASMA CENTERS THIS YEAR. OVER 190,000 IDF EDUCATIONAL MATERIALS WERE DISTRIBUTED, AND FIVE NEW INFORMATIONAL PUBLICATIONS WERE CREATED.

IDF'S PATIENT ADVOCACY SERVICES FULFILLED OVER 6,600 REQUESTS FROM PATIENTS AND FAMILIES SEEKING EDUCATION, INFORMATION AND ASSISTANCE. LOCATING A SPECIALIST WAS THE NUMBER ONE NEED WITH OVER 1,100 REQUESTS.
